1	Can we have a Word version of the recurring grant form?	Yes, this has been added to the website page.
2	Can partnership/consortium applications be submitted?	Yes. A robust partnership agreement or memorandum of understanding will need to be in place. While organisations need to work together a grant application signed by a board member is required for each organisation which details the element they will be accountable for and the amount of grant required.
3	Is there a word count limit on any of the boxes in the application form?	No, there is not but try to be succinct. If there is detail that you think is relevant and should be included, add it as an appendix and clearly reference it in the appropriate box on the form. Please limit number of appendices
4	Will 'weighting' be applied to questions, showing where prominence will be placed during assessment?	No, this is done for tendering exercises, not grant applications. Bids will be assessed on their demonstrable links to the relevant strategies, how well they match the brief and value for money.
5	Will extra time be given for the substance related brief once it is published?	Yes, the ADP Commissioning group meet on the 27 <sup>th</sup> of October and the ADP Committee on the 29 <sup>th</sup> of October. The timeframe for applications on the joint brief will be extended to give sufficient time for submission of applications.
6	Some organisations can deliver against parts of some briefs, but not all of the brief. With only a few weeks to submit bids, how might organisations be able to consider joint working?	Fife Council may well suggest some opportunities to work jointly after assessing bids, but it would be better if organisations could self-organise ahead of submitting bids. FVA will organise Zoom calls, can facilitate meetings, provide advice and support, and share contact details if that would help.

13	The briefs seem to be designed for a single organisation to deliver everything in the brief, removing all scope for existing, trusted, valued partners to contribute in ways they always have and that remain relevant and important. Can organisations bid to deliver parts of the brief for part of the budget available?	There is opportunity in the grant application process for organisations to collaborate and co-deliver on any one of the briefs bringing particular expertise to achieve the outcomes.  An organisation/s would need to be able to demonstrates how they could meet the objectives of a brief not just one part
14	The application form doesn't seek information on track record/experience of delivering similar services/working with similar client groups etc. Why is that? Isn't that important?	Its correct that these questions are not directly asked within the application but are fundamentally important. This is because the evidence of such experience and delivery of similar services to those being applied for should be apparent throughout the application and supplementary questions and will be reflected positively in the scoring of all questions.
15	What are organisations expected to do if they can contribute to multiple briefs but not deliver on all aspects of those briefs? How many applications must they submit, if they are allowed to submit for any?	Organisations must determine what they wish to apply for against the detail of service briefs, and can apply for multiple briefs
16	Can you advise whether TUPE will apply to any of the briefs/services	Fife Council would consider that TUPE may apply depending on the detail of any particular service being recommissioned but that the implications would be between the individual provider of the services to negotiate.
17	Is there an evaluation scoring matrix – for example, detailing how the submissions will be assessed against quality/price	There is no evaluation scoring matrix around a quality/price mix in the way that there would be within a Contract Tender. An evaluation panel will simply individually score both the overall application and each of the supplementary questions between 0 and 5 with all of the scores being added together to form an overall bid total for each organisation.
18	If an organisation is applying for more than one brief, would each brief need to be fully costed or would the management and admin costs for example need to be allocated between each brief?	You should make a separate grant application for each service brief that you are bidding for funds within and hence a separate budget within each application. If you have costs that are spread over more than one brief or even wider parts of the service, then you should include a proportionate amount of the overall costs within each budget that truly reflects the parts of that expense which relates to the specific brief. In simplest terms, if you have an overall admin cost that covers 2 service brief areas then put half in each budget.

19	Can you advise on where to find a word document of the Service Brief Guidance & Supporting Questions which contains the six 200 words supporting questions for the Children's Services grant applications? I can only seem to find a PDF which can't be edited.	A Word version of this document is now available on the FVA website.
20	Providers were asked about additional funding sources and asked to respond with very little time. What is this for? Why was it so urgent? Is this part of the assessment process for awarding grants?	Information was requested to add to the mapping of services and has been discussed at the Strategic Commissioning group which Kenny and Laura attend and at previous Committee meetings. This information will not be part of the assessment process for awarding grants but does provide a helpful overview.
21	Why is the ADP brief delayed, who exactly will be meeting to resolve it (the original date given wasn't a date the ADP was scheduled to meet)?	The proposal to develop a joint brief for ADP and E&CS commissioned services provides an opportunity to streamline services and further develop an innovative and collaborative model. This requires discussion at the ADP Committee and ADP Commissioning group to seek approval. Dates are set by the ADP Coordinator and have been adjusted to ensure this is tabled for discussion as a matter of priority.
22	Further to a previous question, why would each individual member of a joint bid be required to submit a grant funding application if they won't be receiving a grant from the Council? Isn't it just the lead agency that applies and is the grant recipient?	Good Governance ensures that funding should be given to individual organisations as each organisation as a registered charity should be seen to receive funding from the local authority not from a third party therefore should submit on behalf of their board an application. This ensures that if any issues occur then it is with individual organisations.
23	Can organisations bid to deliver part of a brief?	This question has been answered in terms of a response to question 6 and 13. The outcomes required for each service brief could be achieved by single organisations or those who seek to deliver as part of a partnership model. If an organisation can only deliver part of a brief, they need to consider how the other components/outcomes would be achieved to meet the requirements of the service brief.
24	Can organisations bid to deliver in certain parts of Fife or is Fife Council only going to fund bigger organisations?	This question has been covered in the response to question 8. Organisations can submit applications to deliver in one or a number of areas in Fife. Each application will be considered on its merit in line with the grant application process.

26	Some funded activity that is benefitting children, young people and families has been omitted entirely from the briefs. Is the Council saying that they will cease funding that activity and those organisations from April 2021?	The briefs have been developed considering the strategic needs assessment, priorities within the Children & Family Strategy and budget, ensuring a focus on vulnerable children and families. An impact assessment will be undertaken to consider any implications and contingency for organisations who may not be successful in their grant application.
27	Some of the legislative context from one brief meets more of what we deliver but the proposed outcomes of the other brief is maybe a better fit for us and therefore it is quite difficult to choose one brief over the other. What is the most critical aspect of the briefs to help the decision making? Is it meeting the proposed outcomes, is it the age range as proposed, or is it full alignment with the policy context?	The information included in the service briefs aim to provide the context considering legislation, policy drivers, strategic needs assessment and the C&F strategy. Briefs are designed to illustrate identified need and core components regarding the delivery model. All information is relevant to assist organisations to make an application to evidence how they can achieve the required outcomes which will be measured within the context of a Service Level Agreement
28	Upon reading the briefs, they look like they may have been developed in isolation, there seems to no continuity of support/transition/pathway arrangements featuring within them. Is that intentional?	The briefs have been developed considering the strategic needs assessment and priority objectives within the C&F strategy. Transitions have been considered as well as current processes in Fife primarily the Child Wellbeing Pathway alongside legislative requirements
